

OFFICIAL PROMOTION RULES (the “Official Rules”)

VOID WHERE PROHIBITED OR RESTRICTED BY LAW. ALL UNITED STATES FEDERAL, STATE, AND LOCAL LAWS APPLY. NO PURCHASE OR PHOTO PARTICIPATION NECESSARY TO ENTER OR WIN.

General Description:

The Nashville Kane Brown Trip Giveaway (the “Promotion”) is conducted by [Appleton International Airport](#) (“Sponsor”). Registration for the Promotion must be completed at <https://atwairport.com/contests-giveaways/win-a-trip-to-see-kane-brown-in-nashville>. Upon registration, all participants unconditionally agree to and accept these Official Rules.

Promotion Period: Friday, January 20, 2023 7 a.m. CST to Sunday, February 12, 11:59 p.m. CST (the “Promotion Period”).

Eligibility:

The Promotion is open to all Wisconsin and Upper Peninsula of Michigan residents, age twenty-one (21) and over as of the exception where prohibited or restricted by law. Participants can only win one prize once per year if valued over \$300. Selection of Winners:
