Amount of Other Than Car Rental Concessions: Anticipate gross revenue in excess of \$200,000.

Name of Recipient: Appleton International Airport (ATW)

Airport Category: Small Hub* (Based on 2021 Passenger Boarding Data FAA)

Goal Period: FY-2023-2024* - October 1, 2022 through September 30, 2024

*Note: The ACDBE goal computation is reduced to two years due to the airport classification changing from a non-hub to a small hub in 2022. The ACDBE goal computation will be recomputed in October 2024 for FFY 2025/2026/2027 on the normal cycle for a small hub facility.

Overall Three-Year Goal:

40.11%, to be accomplished through 1.10% RC and 39.01% RN

The Appleton International Airport (ATW) has determined that its market area is primarily Northeast Wisconsin. This market area was chosen based on historical participation from Wisconsin certified firms able and willing to travel to ATW to provide goods and services. The businesses providing goods and services are certified as ACDBE's in the Wisconsin Department of Transportation (WisDOT) Unified Certification Program (UCP).

Base of Goal

To calculate the base of the goal Appleton International Airport considered the previous 3 years of gross concession receipts and the projected potential concession revenue (gross receipts) three years into the future including upcoming new opportunities.

The Appleton International Airport estimates that revenues to existing non-car rental concessions will likely increase by 10% annually due to market and anticipated passenger forecasts using ATW.

To calculate the base of the goal for non-car rental concessions:

(2022) \$5,112,434

(2023) \$5,112,434 + 10%(511,243) = \$5,623,677 (2024) \$5,623,677 + 10% (\$562,368) = \$6,186,045

\$5,623,677 + \$6,186,045 = \$11,809,722 is the Appleton International Airport's base of the goal for non-car rental concessions for FFY 2023/2024.

The non-car rental businesses operating at the Appleton International Airport and offering service to the public includes the following businesses. The contracts for these concessions are expected to extend over the period of this triennium.

Methodology used to Calculate Overall Goal

Goods and Services

The Appleton International Airport anticipates the goal can be met by including the purchase from ACDBEs of goods and services used in businesses conducted at the airport. We, and the businesses at the airport, shall make good faith efforts to explore all available options to achieve, to the maximum extent practicable, compliance with the goal through direct ownership arrangements, including joint ventures and franchises. The dollar value from purchases of goods and services from ACDBEs may be added to the numerator, and the dollar value from purchases of goods and services from all firms (ACDBEs and non-ACDBEs) may be added to the denominator.

Prime Concessions

It is also noted First Class Concessions (Wisconsin Certified ACDBE) operates the restaurants at ATW as a Prime Concessionaire. The two restaurants operated by First Class Concessions are Landside Café' and Fox City Eatery. Based on FY 2022 gross

receipts for all non-car rental concessions, the anticipated gross revenues for these restaurants' accounts for 24.65% of all non-car rental annual revenues at ATW. Since this business operates at ATW as Prime Concession under a Race-Neutral (RN) Agreement, the goal will be included in the goal computation as Race-Neutral participation.

Step 1: 23.51(c)

We determined the base figure for the relative availability of ACDBEs other than car rentals. The base figure was calculated as follows:

Numerator: Ready, willing, and able non-car rental ACDBEs in the market area

Denominator: All ready, willing and able non-car rental concession firms in the market area

The Total Base Goal for Step 1 is therefore calculated by

After calculating a base figure of the relative availability of ACDBEs, we examined evidence to determine what adjustment was needed to the Step 1 base figure in order to arrive at the overall goal.

Considering the DBE participation for the last five years and arranging this historical data of DBE accomplishments from low to high, (67.72%, 77.12%, 79.27%, 83.47%, 91.35%,) we arrive at a central tendency or median accomplishment of 79.27%. To Appleton International Airport (ATW)

arrive at an adjusted overall DBE goal, we added our Step 1 base figure (0.95%) with our Step 2 adjustment figure (79.27%) and then averaged the total arriving at an overall adjusted goal of 40.11% for DBE Participation.

The Appleton International Airport will use race-conscious measures (e.g., set contract goals) to obtain the RC portion of the goal. We believe the RC portion of the goal will be computed by adding the goal computed in step 1 (0.95%) with the median RC accomplishment from step 2 (1.24%) then averaging the total arriving at adjusted overall goal of 1.10%. This will accurately reflect DBE RC participation that can be achieved for the types of comparable project work being awarded during this three-year overall goal period.

The race neutral (RN) portion of the goal is computed by taking the overall goal of 40.11% and subtracting the RC goal of 1.10% arriving at 39.01%.

There are no applicable disparity studies for the local market area or recent legal case information available to show any evidence of barriers to entry or competitiveness of ACDBEs.

Breakout of Estimated Race-Neutral & Race Conscious Participation Section 23.51

The Appleton International Airport will meet the maximum feasible portion of its overall goal by using race-neutral means of facilitating ACDBE participation. The Appleton International Airport uses the following race-neutral measures.

- 1. Locating and identifying ACDBEs and other small businesses who may be interested in participating as concessionaires under 49 CFR Part 23;
- 2. Notifying ACDBEs of concession opportunities and encouraging them to compete, when appropriate;
- 3. Providing technical assistance to ACDBEs in overcoming limitations, such as inability to obtain bonding or financing;
- 4. Providing information concerning the availability of ACDBE firms to competitors to assist them in obtaining ACDBE participation; and
- 5. Establishing a business development program (see 49 CFR Part 26.35); technical assistance program or taking other steps to foster ACDBE participation in concessions.

We estimate that, in meeting our overall goal of 40.11%, we will obtain 39.01% from race-neutral participation and 1.10% through race-conscious measures. The anticipated race-neutral participation is based on the following:

- 1. The extent that you've exceeded your ACDBE goals in the past uniform reporting.
- 2. Proactively working with Concession vendors to increase awareness and encourage extension of your race-neutral business assistance efforts;
- 3. ACDBE participation on concession agreement with First Class Concessions;

We project that race-neutral measures, standing alone, are not sufficient to meet our overall goal, thus we will use the following race-conscious measures to meet the overall goal:

1. We will establish contract goals for ACDBE opportunities in our contract agreements with Airport Concessionaires to achieve our RC participation.

In order to ensure that our ACDBE program will be narrowly tailored to overcome the effects of discrimination, concession specific goals will adjust the estimated breakout of race-neutral and race-conscious participation as needed to reflect actual ACDBE participation (see 26.51(f)) and we will track and report race-neutral and race conscious participation separately. For reporting purposes, race-neutral ACDBE participation includes, but is not necessarily limited to, the following: ACDBE participation through a prime contract that an ACDBE obtains through customary competitive procurement procedures; ACDBE participation through a subcontract on a prime contract that does not carry ACDBE goal; ACDBE participation on a prime contract exceeding a

To calculate the base of the goal Appleton International Airport considered the previous 3 years of car rental expenditures/purchases and the projected potential expenditures/purchases three years into the future including upcoming new opportunities.

The Appleton International Airport estimates that expenditures/purchases to existing car rental concessions is estimated to increase by an average 9% over FFY 2023/2024.

\$7,947,829+ \$8,663,134 = **\$16,610,963** is the Appleton International Airport's base of the goal for expenditures/purchases for car rental concessions.

The following are not included in this base: (a) non-car rental operations.

If a new concession opportunity arises prior to the end of this goal period and the estimated average of annual gross revenues are anticipated to be \$200,000 or greater, ATW will submit to the FAA an appropriate adjustment to the overall goal. This will be submitted to FAA for approval no later than 90 days before issuing the solicitation for the new concession opportunity. (23.45(i)).

Methodology used to Calculate Overall Goal

Goods and Services

We are not aware of any certified ACDBE businesses in Wisconsin offering car rental services to the general public therefore our goal is based on ACDBE's providing goods and services to the car rental agencies operating at the Appleton International Airport.

Fleet purchases are included in the goal computation but has 0 participation due to no certified ACDBE businesses in Wisconsin.

Car Rentals stated the services they may need are: fleet, key blanks, oil change services, insurance, office supplies, janitorial services, tires, auto repair services, auto part supplies, security services, payroll services, towing services, car wash, landscaping services and freight transportation.

Considering the ACDBE participation and arranging this historical data of ACDBE accomplishments from low to high, (2.24%, 3.33%, 5.45%, 6.51%, 7.44%) we arrive at a central tendency or median accomplishment of 5.45%. To arrive at an adjusted overall goal, we added our Step 1 base figure (0.37%) with our Step 2 adjustment figure (5.45%) and then averaged the total arriving at an overall adjusted goal of 2.91%.

The Appleton International Airport will use race-conscious measures (e.g., sets contract goals) to obtain the RC portion of the goal. We believe this adjusted overall goal of 2.91% will accurately reflect ACDBE participation that can be achieved for the types of comparable project work being awarded during this three-year overall goal period.
