

OFFICIAL PROMOTION RULES (the “Official Rules”)

VOID WHERE PROHIBITED OR RESTRICTED BY LAW. ALL UNITED STATES FEDERAL, STATE, AND LOCAL LAWS APPLY. NO PURCHASE OR PHOTO PARTICIPATION NECESSARY TO ENTER OR WIN.

General Description:

The Appleton Airport 60th Anniversary Giveaways (the “Promotion”) is conducted by [Appleton International Airport](https://atwairport.com/contests-giveaways/60th-anniversary-giveaway/) (“Sponsor”). Registration for the Promotion must be completed at <https://atwairport.com/contests-giveaways/60th-anniversary-giveaway/>

Upon registration, all participants unconditionally agree to and accept these Official Rules.

Promotion Period: August 1, 2025 from 6:00 a.m. CST – August 29, 2025, 6:00 a.m. CST (the “Promotion Period”).

Eligibility:

The Promotion is open to all Wisconsin and Upper Peninsula of Michigan residents, age eighteen (18) and over as of the exception where prohibited or restricted by law. Participants can only win one prize once per year if valued over \$300. Sponsor, and its respective parent, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, prize sponsors and other agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, “Promotion Parties”), and the immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each (whether related or not), are not eligible to participate or win.

Registration:

All entries must be received by August 29, 2025 (the “Registration Deadline”). By submitting a registration, each participant agrees to release, discharge, defend and hold harmless the Promotion Parties from any claim or liability arising from or related to submitting a registration.

Selection of Winners:

The 6 winners (a “Prize Winner”) will be selected by random drawing on August 8th, August 15th, August 22nd, and the Grand Prize winner will be selected August 29th.

The Prize Winners will be contacted by email or phone.

If any Prize Winner cannot be contacted within three (3) calendar business days of the first notification attempt, if any Prize or Prize notification is returned as undeliverable, if any Prize Winner rejects his/her Prize or in the event of non-compliance with these Official Rules and requirements, such Prize will be forfeited and an alternate Prize Winner will be selected from all remaining eligible entries.

Prize and Approximate Retail Values ("ARV"): \$600

The potential Prize Winners will be required to complete and return Sponsor's Affidavit of Eligibility and Liability Form if the prize is valued over \$600. The Promotion Parties reserve the right to cancel the Promotion for any reason that they deem appropriate, including, without limitation, a computer virus, bug or other technical problem(s) that corrupts the administration or security or proper functioning of the Promotion. Should the Promotion be canceled prior to the Registration Deadline, notice will be sent to all participants.

The Promotion Parties reserve the right to amend these Official Rules and policies.

Prize Winners of any Prize are solely responsible for all applicable federal, state, and local taxes.
